**ST. RAPHAEL CATHOLIC CHURCH, SPRINGFIELD MN  
COUNCIL OF CATHOLIC WOMEN BY-LAWS**

**ARTICLE I – BASIC INFORMATION**

- SECTION 1** This organization shall be known as the St. Anne’s Council of Catholic Women.
- SECTION 2** This council is a member of the National Council of Catholic Women (NCCW) and the New Ulm Diocesan Council of Catholic Women Deanery 1 (NUDCCW).
- SECTION 3** The council year and fiscal year will begin on July 1 and end June 30.

**ARTICLE II – OBJECTIVES**

- SECTION 1** This organization acts through its affiliated membership to support, empower and educate all Catholic women in spirituality, leadership and service. Through our commissions and committees we respond with Gospel values to the needs of the Church and society in the modern world.

**ARTICLE III – MEMBERSHIP**

- SECTION 1** All women of the parish, 18 or over, are members of this organization.
- SECTION 2** When a member feels they no longer can physically contribute to their group, they may contact the group chairperson and request to be an honorary member.

**ARTICLE IV – DUES**

- SECTION 1** St. Anne’s Council of Catholic Women pays annual dues to NCCW, NUDCCW and Deanery 1 CCW for membership as billed.
- SECTION 2** Member dues will be billed in July and are to be paid by December 31. Honorary Members are exempt from paying dues.

**ARTICLE V – OFFICERS**

- SECTION 1** The officers of the St. Anne’s Council of Catholic Women shall be:  
President, Vice-President, Secretary, and Treasurer
- SECTION 2** The President shall hold office for a two year term, after serving as Vice President for two years and will continue her service as Leadership Commission for two years following.
- SECTION 3** The Vice President shall hold office for a two year term followed by a two year term as President and will continue her service as Leadership Commission for the two years following.
- SECTION 4** The Secretary and Treasurer shall hold office for two years.
- SECTION 5** New officers installed will begin their term July 1.

## ARTICLE VI – INSTALLATION

- SECTION 1** A nominating committee shall be appointed at the January meeting to look for the new slate of officers, which shall be presented at the March meeting. Installation of officers shall take place in May.
- SECTION 2** Unexpected vacancies in office, with the exception of the President, shall be filled as soon as the CCW board can replace them.

## ARTICLE VII – DUTIES OF OFFICERS

- SECTION 1** It shall be the duty of the President to lead all parish CCW meetings and perform all duties pertaining to the office. She will attend Deanery 1 meetings as a representative of St. Anne’s CCW.
- SECTION 2** The Vice President shall perform the duties of the President in her absence and shall assist the President as needed.
- SECTION 3** The Secretary shall keep an accurate record of all parish CCW meetings. Minutes shall be recorded in a permanent record book. She shall perform such other secretarial duties as requested by the President.
- SECTION 4** The Treasurer shall keep an accurate record of all receipts and disbursements. She shall bill and collect all dues and pay bills approved by the President and/or board. She shall present a statement of accounts at each CCW meeting.

At the end of the fiscal period, she shall make her records available to be audited by an outside source. She shall provide a final year-end statement at the September meeting.

- SECTION 5** Board members are encouraged to attend all monthly CCW meetings, Diocesan Leadership and Development Training, the CCW Spring and Fall Gatherings and the diocesan annual convention during their terms.

## ARTICLE VIII – MEETINGS

- SECTION 1** The CCW meetings shall be held on the third Thursday of September, November, January, March and May. Special meetings may be called by the President or upon request of three members of the CCW board.
- SECTION 2** A quorum for the CCW meeting shall consist of not less than three members.

## ARTICLE IX – SERVICE GROUPS

- SECTION 1** All St. Anne’s CCW members will be divided into one of eight service groups named after female saints (St. Barbara, St. Catherine, St. Delores, St. Elizabeth, St. Frances, St. Genevieve, St. Helen, and St. Irene).
- SECTION 2** The leaders of each group shall be a chairperson and vice chairperson. The vice chairperson shall become the chairperson the following year. Both shall be responsible to find a new vice chairperson from within their group for the following year.
- SECTION 3** The group chairperson will be responsible for contacting their group members to provide cakes and salads for funeral luncheons and other activities that may be assigned.

**SECTION 4** The Parish Secretary shall be responsible for assigning new parish members to a group. She will give the names of the newcomers to the CCW Secretary so she may send a card of welcome or arrange a visit. The Parish Secretary should also notify the group chairperson of their new member.

#### **ARTICLE X – SPECIAL COMMITTEES**

**SECTION 1** Special Committees shall be appointed by the President at her discretion.

All Special Committees shall report at the meetings.

#### **ARTICLE XI – COMMISSIONS**

**SECTION 1** It shall be the policy of the St. Anne’s CCW, of the New Ulm Diocesan CCW, to follow the Commission system as set forth by the National Council of Catholic Women with Commission Coordinators paralleling those of the Diocesan Council of Catholic Women. The commissions are:

1. Spirituality Commission
2. Service Commission
3. Leadership Commission

**SECTION 2** These Commission Coordinators shall serve a minimum term of two years.

**SECTION 3** St. Anne’s CCW will have the following committees:

1. Scholarship Committee
2. Reverence for Life Committee
3. Cheer & Hospitality Committee

**SECTION 4** These Committee Coordinators shall serve a minimum term of two years.

**SECTION 5** Each Commission or Committee Coordinator shall report at each meeting.

All Commission or Committee Coordinators are encouraged to attend all meetings during their term. They should notify the President if they are unable to attend the meeting. If unable to attend the meeting, they are asked to provide a written report.

#### **ARTICLE XII – AMENDMENTS**

**SECTION 1** These by-laws may be amended by a 2/3 vote at any meeting as needed.

#### **ARTICLE XIII – RULES OF ORDER**

**SECTION 1** The current Robert’s Rule of Order shall govern all meetings of the CCW board except when in conflict with these by-laws.
